

MINUTES OF THE CITY COUNCIL, VICTOR, IOWA, JULY 11, 2012

The city council met in regular session at city hall at 7:00 P.M. Present were council members Faga, Smith, Robinson, and Cavin. Sternhagen was absent. Mayor Roger Pawlak called the meeting to order.

Ed Brinton, engineer, MMS discussed plans for repairs at the sewer plant. Bids will come in August, with construction in the fall, subject to Iowa DNR approval. The council approved payment of a \$100 application fee to Iowa DNR.

Duke Wilgenbusch discussed plans for decorative street lighting along Washington Street between 3rd and 2nd streets. There will be 10 lights at an estimated cost of \$53,450. There will be a Prairie Meadows grant application due in September that could help fund the project.

The city will begin repairs to the post office building as soon as the city closes on the purchase.
